## FOR INTERNATIONAL PLAYERS

NBA Players who are not are citizens or permanent residents of the United States or Canada are eligible for the benefits described below. Please refer to your summary of benefits for information about eligible services and your share of the cost of services.

<b>Medical Benefits</b> <i>(Benefits For Medical Services And Supplies)</i>	<ul style="list-style-type: none"><li>• <b>Benefits Received in the US</b><ul style="list-style-type: none"><li>○ You can use any medical provider, but using a Cigna provider reduces your out-of-pocket costs.</li><li>○ <b>In-Network:</b> No cost for preventive care. Copayments for visit to primary care or specialist (\$25), emergency room (\$100) and urgent care facility (\$25). No annual deductible and no out-of-pocket maximum.</li><li>○ <b>Out-of-Network:</b> \$500 (single) / \$1,500 (family) deductible, then Plan pays 80%; maximum out of pocket: \$1,500 (single) / \$4,000 (family).</li></ul></li><li>• <b>Benefits Outside the US</b><ul style="list-style-type: none"><li>○ No cost for preventive care; no copayments, annual deductible or out-of-pocket maximum.</li></ul></li></ul>

<b>Dental Benefits</b>	<ul style="list-style-type: none"><li>• <b>Benefits Received in the US</b><ul style="list-style-type: none"><li>○ You can use any dental provider, but using a Cigna provider generally reduces your out-of-pocket costs. Out-of-network services are subject to the reasonable and customary allowance (i.e., the amount that Cigna determines is typical for the service in the geographic area in which you obtain the service).</li><li>○ <b>In-Network and Out-of-Network:</b> No cost for preventive care. \$25 (single) / \$75 (family) deductible. For non-orthodontia services, the Plan pays 90% for basic and 60% for major services up to a \$3,000 annual maximum per person. <b>Eye-Care Benefits</b> <i>(Benefits For Vision Exams And Eyewear)</i>	<ul style="list-style-type: none"> <li>You are covered for vision services through EyeMed and Cigna Vision.</li> <li><b>EyeMed Benefits (U.S.):</b> <ul style="list-style-type: none"> <li>You can use any eye-care provider, but using an EyeMed provider provides greater benefits.</li> <li><b>In-Network:</b> No cost for annual exams and lenses. <b>Life and Accidental Death &amp; Dismemberment (AD&amp;D) Coverage</b> <i>(Financial Protection In The Event Of Death Or Accidental Loss)</i>	<ul style="list-style-type: none"> <li>Flat \$1,000,000 payable to your beneficiary if you die from any cause while covered.</li> <li>An additional benefit is payable, according to a schedule, if you die or suffer a loss as the result of a covered accident.</li> </ul>	<p><b>NBA Players' Health Service Center:</b> 855-497-6669, Option 1 then Option 4</p>
<b>Disability Benefit</b> <i>(Financial Protection In The Event Of Disability)</i>	<ul style="list-style-type: none"> <li><b>Eligibility:</b> <ul style="list-style-type: none"> <li>Active players only, so long as the disability occurs while you are covered and before age 35.</li> </ul> </li> <li><b>Benefits:</b> <ul style="list-style-type: none"> <li>Insured by Houston Casualty Company ("HCC").</li> <li>Subject to the Collective Bargaining Agreement, the disability benefit is \$2,500,000 payable to you after a 12-month elimination period during which you remain permanently totally disabled.</li> <li>Must be repaid to HCC if you ever play in another NBA regular season game.</li> </ul> </li> </ul>	<p><b>NBA Players' Health Service Center:</b> 855-497-6669, Option 1 then Option 5</p>
<b>Tuition Reimbursement Benefit</b> <i>(Reimburses Eligible Education-Related Costs For Qualifying Education Programs)</i>	<p>The Tuition Reimbursement benefit encourages the growth and development of your skills, abilities, and knowledge off the court by providing reimbursement for eligible academic fees, including textbooks and tuition costs for qualifying education programs. ## POST CAREER BENEFITS: *PROTECTION FOR YOUR FUTURE*

<b>401(k) Savings Plan</b> (A Savings Plan For Retirement)	<ul style="list-style-type: none"> <li>You will be automatically enrolled in the pre-tax 401(k) contribution each year equal to the maximum permitted by law, unless you timely elect otherwise. The maximum contribution for 2024 is \$23,000.</li> <li>For 2024, your team matches 140% of your pre-tax savings (in 2024, a match of \$32,200 for players who contribute the maximum of \$23,000).</li> <li>You can also contribute an additional amount on an after-tax basis.</li> <li>All contributions are credited with investment earnings/losses while in the plan. You select investments from a menu of options.</li> <li>All contributions and investment earnings grow tax-deferred while in the plan.</li> <li>All contributions are always 100% vested.</li> </ul>	<b>Voya Financial:</b> 800-584-6001 <a href="https://voyaretirement.voyaplans.com/eportal/welcome.do">Voyaretirement.voyaplans.com/eportal/welcome.do</a>
<b>Pension Plan</b> (A Plan That Provides A Benefit For Retirement)	<ul style="list-style-type: none"> <li>Once you are credited with three years of NBA service, you can receive your normal retirement monthly benefit at age 62 or reduced benefit as early as age 45; a portion of your benefit may be available as a lump sum.</li> <li>In general, you are credited with a year of NBA service for an NBA season during which you are either: <ul style="list-style-type: none"> <li>on the active list, inactive list, or two-way list of any NBA team as of February 2 of that season (excluding players under a 10-day contract), or</li> <li>on the active list of one or more NBA teams for at least 50% of regular season games during that season.</li> </ul> </li> <li>Your pension benefit grows as you earn additional years of NBA service (subject to IRS maximum benefit limits).</li> </ul>	<b>Zenith:</b> 833 NBA-PLAY (622-7529) <a href="mailto:NBAPlayerPension@zenith-american.com">NBAPlayerPension@zenith-american.com</a>  <a href="https://www.mygameplan.com">www.mygameplan.com</a> (for personalized information)
<b>HRA Benefit</b> (A Health Reimbursement Account you can use to Pay for Healthcare Expenses or Obtain Coverage after your NBA Playing Career Ends)	<ul style="list-style-type: none"> <li>When provided for under the Collective Bargaining Agreement, you receive a tax-free contribution to your health reimbursement account (HRA) for each year of NBA service (as described above). The contribution is \$30,000 per season (with a lifetime maximum of \$150,000). You may access your HRA funds only after earning 3 years of NBA service.</li> <li>Tax-free reimbursements of eligible out-of-pocket healthcare costs (e.g., copayments, deductibles, and prescription and over-the-counter drugs) and certain post-career health insurance coverage costs.</li> </ul>	<b>Zenith American Solutions</b> 877-864-3522 <a href="https://www.zenithflex.com">www.zenithflex.com</a>
<b>Post Career Income Plan</b> (A Plan That Provides Guaranteed Monthly Income Soon After Your NBA Career Ends And Continuing Until Your Pension Begins)	<ul style="list-style-type: none"> <li>The plan provides guaranteed monthly income through insured annuities soon after your NBA career ends (but not before age 30).</li> <li>When provided for under the Collective Bargaining Agreement, you receive a collectively bargained team contribution for each year of NBA service (as described above), a portion of which is tax-deferred.</li> <li>In addition, you may elect to contribute 2%, 5%, 7% or 10% of your eligible pay. <b>Retiree Health and Welfare Benefits</b> <i>(Medical, Dental and Vision Benefits For Eligible Retired Players And Their Families)</i>	<p>Once you are credited with three years of NBA service, you are eligible for the following benefits if you live in the US:</p> <ul style="list-style-type: none"><li>• <b>Retiree Medical Benefit:</b> Eligible retired players may elect retiree healthcare coverage through UnitedHealthcare® for themselves and, in some cases, their families at no charge to the player for the cost of premiums for such coverage.<ul style="list-style-type: none"><li>○ You can use any provider for medical care, although using a UnitedHealthcare® network provider generally reduces your out-of-pocket costs.</li><li>○ UnitedHealthcare® provides emergency coverage outside of the US.</li></ul></li><li>• <b>Retiree Dental Benefit:</b> Retiree dental coverage is offered through Cigna. The cost of this coverage is 100% paid by the retired player. For international coverage only emergency services are offered. (For example, an emergency root canal performed outside of the US would be covered, but a routine cleaning or cavity filling performed outside of the US would not be.) Reimbursement of eligible international services would be covered at the out-of-network level.</li><li>• <b>Retiree Vision Benefit:</b> Retiree vision coverage is offered through EyeMed. The cost of this coverage is 100% paid by the retired player. For international coverage only emergency services are offered. (For example, temporary emergency glasses obtained outside of the US would be covered, but a routine eye exam performed outside of the US would not be.) Reimbursement of eligible international services would be covered at the out-of-network level.</li></ul>	<b>NBA Players' Health Service Center:</b> 855-497-6669, Option 2
